The water meters are read and billed monthly. A baseline allowance of 500 cubic feet of water consumption is included in the base monthly charge. Each additional 100 cubic feet of water consumption is charged an additional \$3.14 per 100 cubic feet.

Sewer Charges:

Domestic and Business sewer charges are based on water consumption. The first 400 cubic feet of water consumption is included in the base sewer rate charge of \$104.31 per month. Each additional 100 cubic feet of water consumption is charged an additional \$9.75 per 100 cubic feet.

LATE FEES:

Charges are due and payable upon receipt of the bill. I understand to avoid penalties and late charges (10 %)
